#### 2003 Ph.D. Jamboree

The first-ever North American Jamboree for Ph.D. students in Planning will be held at SCARP-UBC from June 9 to 14, 2003. So far, 35 participants have been accepted from such schools as MIT, Berkeley, Cornell, UCLA, University of Washington, and Wisconsin-Madison along with several Canadian universities (see list below).

Special visitors include Professor Bent Flyvbjerg of the University of Aalborg, Denmark and Professor Anastasia Loukaitou-Sideris, current chair of the Department of Urban Planning at UCLA.
